Dear Chairman Baucus and Ranking Member Hatch:

The latest tax reform options paper on Tax-Exempt Organizations and Charitable Giving demonstrates the thoughtful consideration that members of the Senate Finance Committee are giving to the potential impacts of changes or limits to the charitable deduction. As lawmakers debate comprehensive tax reform, we appreciate the tough decisions you face in addressing our nation's fiscal challenges, strengthening our tax system and helping restore our economy.

As a Coalition of more than 60 diverse nonprofits, foundations and other charitable organizations, we are grateful for the opportunity to inform your deliberations. We are encouraged that members of Congress understand the unique role and value of charitable giving in our communities. We are also committed to working with you to ensure there is a clear understanding of how some of the options outlined in this paper might impact charitable giving and potentially hurt those most in need.

As you know, the century-old charitable tax deduction is a powerful American tradition that encourages people to donate a portion of their income - often more than they would have otherwise given - to support others in need and to strengthen communities. If Congress changes the existing policy in a way that restricts this long-standing charitable giving incentive, donations will go down and the communities we serve and the individuals we help would suffer the most - not the donors.

As the Finance Committee contemplates tax reform we urge you to protect the charitable tax deduction. We look forward to continuing our work with you, your committee colleagues, and the entire Congress to identify the best ways to preserve the unique nature of the charitable deduction and our communities that depend on it.
