

What You Need to Know About: The Annual 2024 Accreditation Fee

Fee Details:

- All museums participating in the Accreditation Program pay this fee each year, except the year their Self-Study is due.
- Fees cover only a portion of the annual costs of operating the Accreditation Program.
- The fee covers the period from January 1 to December 31, 2024.
- The fee **must be paid by January 30, 2024** to keep the museum's accredited status in good standing.
- Non-payment may result in probation, which could lead to revocation of accredited status or application.
- This fee is **not your AAM member dues**. AAM membership is voluntary and is not required to become or remain accredited. Membership benefits include lower/waived accreditation fees, as outlined below.
- Alliance museum membership dues are billed separately, and are distinct from, the Accreditation Annual Fee.

- Your annual fee is based on a combination of your institution's Alliance membership status at the time your invoice is generated and its last/next accreditation Self-Study due date.

Payment Details and Options:

Payment is required in full and is **due no later than January 30, 2024**.

Adjustments...If you were charged the higher rate but:

- Think your museum already is an Alliance Tier 2 or Tier 3 member: contact the Alliance Member Services team at 866-226-2150 or membership@aam-us.org to clarify its status.
- Want to renew, join, or upgrade your museum's membership to get a discounted rate: within 30 days contact the Alliance Member Services team who will help you with your membership payment and will arrange for an adjustment of your accreditation fee. - You already sent your Alliance Tier 2 or Tier 3 membership payment but it has not arrived/been processed yet: note this on your invoice payment slip, deduct the difference and pay the correct amount.
