

#### Public Domain in the United States

If the work was published prior to 1930, it is in the public domain.

2. For works published between 1930 and March 1, 1989:

a. Public Domain = Published between 1930 and 1977 without a notice. (Note: If the work published during this period has a notice, it may be protected for 95 years from the date of publication.)

b. Public Domain = Published between 1978 and March 1, 1989 without a notice and was not registered within the next five years.

(Note: If the work published during this period has no notice, but was registered, it is protected for 70 years from the death of the creator.)

c. Public Domain = Published between 1930 and 1963 with a notice, but copyright was not renewed, it is in the public domain.

3. After March 1, 1989, all works (published and unpublished) are protected for 70 years from the date the creator dies. For works of corporate authorship (works made for hire), the copyright term is the shorter of 95 years from publication, or 120 years from creation.



A public dedication tool, enables creators to give up their copyright and put their works into the worldwide public domain. Reusers can distribute, remix, adapt, and build up in any medium or format.

#### Fair Use

there isn't a blanket standard, each instance is evaluated separately

#### Four factors that must be evaluated in each case:

- The purpose and character of the use (including whether it is transformative, commercial, non-profit, or educational)
- The nature of the copyrighted work
- The amount and substantiality of the portion to be used
- The effect upon the potential market for the copyrighted work

### Personality (or Publicity) Rights

you've gotten permission to use an image, but what about the person shown in that photograph?

#### Open Access




